History of original corner establishment: Original corner established by J.L. Nowlin, Deputy Surveyor, in 1858, from which sugar 20" bears N5°W 8"1ks. and sugar 8" bears S25°E 30 1ks.

This corner recovered by E.B. Hurst and P. Hansen in 1932. A squared wooden post was offset 33 feet north of corner on a bank on the north side of highway G. This was later referenced with a white post with location tag by Ray Leigh, Consolidated Forester. During the reconstruction of highway G, the highway engineers set a: 1-1/2" iron pipe with white post and location tag at a point 100 feet north of the true corner. This is in line with and north of the P.I. of curve in highway.

Description of corner evidence found: Recovered a 1-1/2" iron pipe projecting 8", and white post with location tag stating true corner is 100 feet south. This white post, witness pipe, and true corner are in line with P.I. hub of curve in highway G.

Description of monument and accessories I established to perpetuate the original location of this corner. Measured 100 feet south from witness corner and set a 1-1/2" x 18' iron pipe flush with the ground for the true corner. This point is on the north shoulder of county trunk highway G. Set a 2-1/2" Berntsen A-1 Federal Monument for S498 witness corner, 55 lks. north from true corner on line with the T37N R14E white post, iron pipe, and P.I. of curve. Cap stamped -Sec. S30 S29 W.C. Projecting 12" above ground. NBT's - Sugar 5" N14°W 106 lks. scribed SC BT. Sugar 7" N33°E 140.5 1ks. scribed SC BT. 1975
