
(b) Describe any record syldence, monument evidence, occupational evidence, testimonial syldence or any other material evidence you considered, and whether the monument was found or placed.

In 1857, Artemas Curtis set a wood post with the following B.T.'s: Sugar, 10", N.58°E., 8 links (5.28 feet); Sugar, 16", S.54°W., 24 links (17.16 feet).

In 1982, H. Neider found a  $1\frac{1}{2}$ " x 7" pipe with remains of burnt post along side.

In 1988, Alan D. Harrison (RLS) searched and found iron pipe as per Neider. No othe evidence recovered. Iron pipe is similar to Goodman Co. fluepipes at other locations in township. Replaced pipe with monument as best evidence of corner location.

- Show a plan view drawing depicting the relevent monuments and reference tles which is sufficient in detail to enable accurate relocation of the corner monument if the corner monument is disturbed. Indicate north.
  - 1. 2½" x 36" aluminum monument with tablet stamped to identify the corner.
  - 2. Sugar, 12", N.60°E., 9.02 feet.
  - Red Pine, 4", S.79°W., 8.93 feet.
  - 4. Red Pine, 5", N.17°W., 25.60 feet.
  - Steel Sign Post, 6', East, 1.39 feet.



(e) Describe any material discrepancy between the location of the corner as restored or reestablished and the location of that corner as previously restored or reestablished by distance and direction. Show the discrepancy on the plan view drawing under (d). above. Show the distances between the corner as previously restored or reestablished and (i) the corner as restored or reestablished, and (2) to at least 2 of the witness monuments shown on the drawing in (d), above.
