Description of original monument and accessories and subsequent restorations:
Surveyed in 1865 by H. and J.L. Nowlin.
40.00 chains North between sections 13 and 14 Set post. Fir, 11", S240, 12 links
Birch, 9", N 260E, 13 links
10 chains South, enter swamp NE & SW
Description of corner evidence found:
No original evidence was recovered. Corner falls in Old Highway 139.
On July 7, 1934, Stewart Morey found a fence line North and West on the West side of
Old Highway 139. He stated that the intersection of the fences was the corner position. On August 4th and August 8th, 1983 I talked to H. Howen and E. Kruger owners in sections
11 and 14 and they both agreed that the corner fell in the center of Old Highway 139 at
the intersect of the fence line to the West.
Description of monument and accessories I established to perpetuate the location of this corner:
From the testimony I received and survey measurements obtained I believe that at the
intersection of the fence line West and the center of Old Highway 139 is the best remaining evidence of the corner position.
At this position I set a $2\frac{1}{2}$ inch diameter aluminum pipe monument, 3 feet long,
6 inches below the road surface with an aluminum cap stamped: T38N RILE, $\frac{1}{4}$, S13, S14, 1983, S-1107
From which the following bear:
