

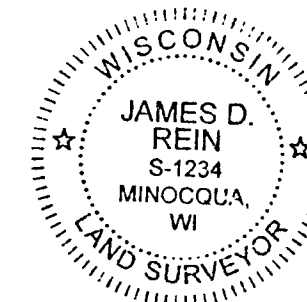

PARCEL -A- (MAP NO. 15-46)

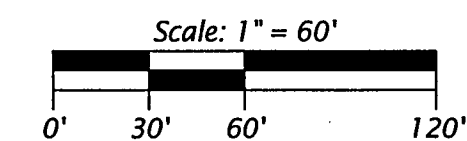
A parcel of land being part of Lot 2 and part of the Platted Road of the First Addition to Upham's Pickerel Lake Plat in Government Lot 7, Section 29, Township 34 North, Range 13 East, Town of Nashville, Forest County, Wisconsin, being parcel "A-" on Map No. 15-46 by Wilderness Surveying, Inc., dated June 5, 2015, more particularly described as follows:

Commencing at the corner common Sections 28, 29, 32 and 33, marked by a capped iron pipe; thence North 00 degrees 45 minutes 19 seconds East for a distance of 1319.87 feet along the east line of Section 29 to the place of beginning, marked by an iron pipe on the north line of Lot 4 Certified Survey Map Document Number 116343, recorded in Volume 2 Certified Surveys, page 261.

Thence along the north line of said Lot 4 Certified Survey Map Document Number 116343, North 89 degrees 22 minutes 02 seconds West for a distance of 24.93 feet to an iron bar; and North 66 degrees 45 minutes 01 seconds West for a distance of 126.64 feet to an iron pipe near the easterly shore of Pickerel Lake on the south line of Lot 1 of the First Addition to Upham's Pickerel Lake Plat; thence South 89 degrees 20 minutes 12 seconds East for a distance of 116.97 feet along the south line of Lot 1 of the First Addition to Upham's Pickerel Lake Plat to an iron pipe; thence continuing South 89 degrees 20 minutes 12 seconds East for a distance of 24.96 feet to an iron pipe on the east line of Section 29; thence South 00 degrees 45 minutes 19 seconds West for a distance of 48.62 feet along the east line of Section 29 to the place of beginning.

Together with and subject to covenants, easements, and restrictions of record.

Said property contains 0.09 acres.
