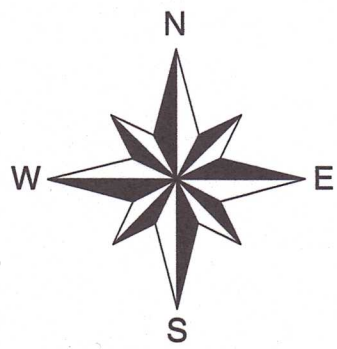
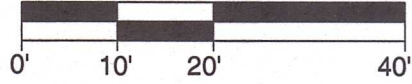


Forest County Grid Bearings:

That part of Government Lot Eight (8) in Section 31, in Township 34 North of Range 13 East, Town of Nashville, Forest County, Wisconsin, bounded and described as follows: Beginning at a point on the Westerly shore of Pickerel Lake, 420 feet Southerly, measured along the lake shore of Pickerel Lake, from an iron pipe set at the Northeast corner of said Government Lot; thence Westerly, parallel with the North Line of said Government Lot to the East line of the private bulldozed road; thence running Southerly and Easterly, along the Easterly and Northerly line of said private bulldozed road, a distance of 50 feet; thence Easterly to a point on the shore of Pickerel Lake, which point is 50 feet Southerly along the lake shore from the point of beginning of the parcel herein conveyed; thence Northerly along the lake shore, 50 feet to the point of beginning.
