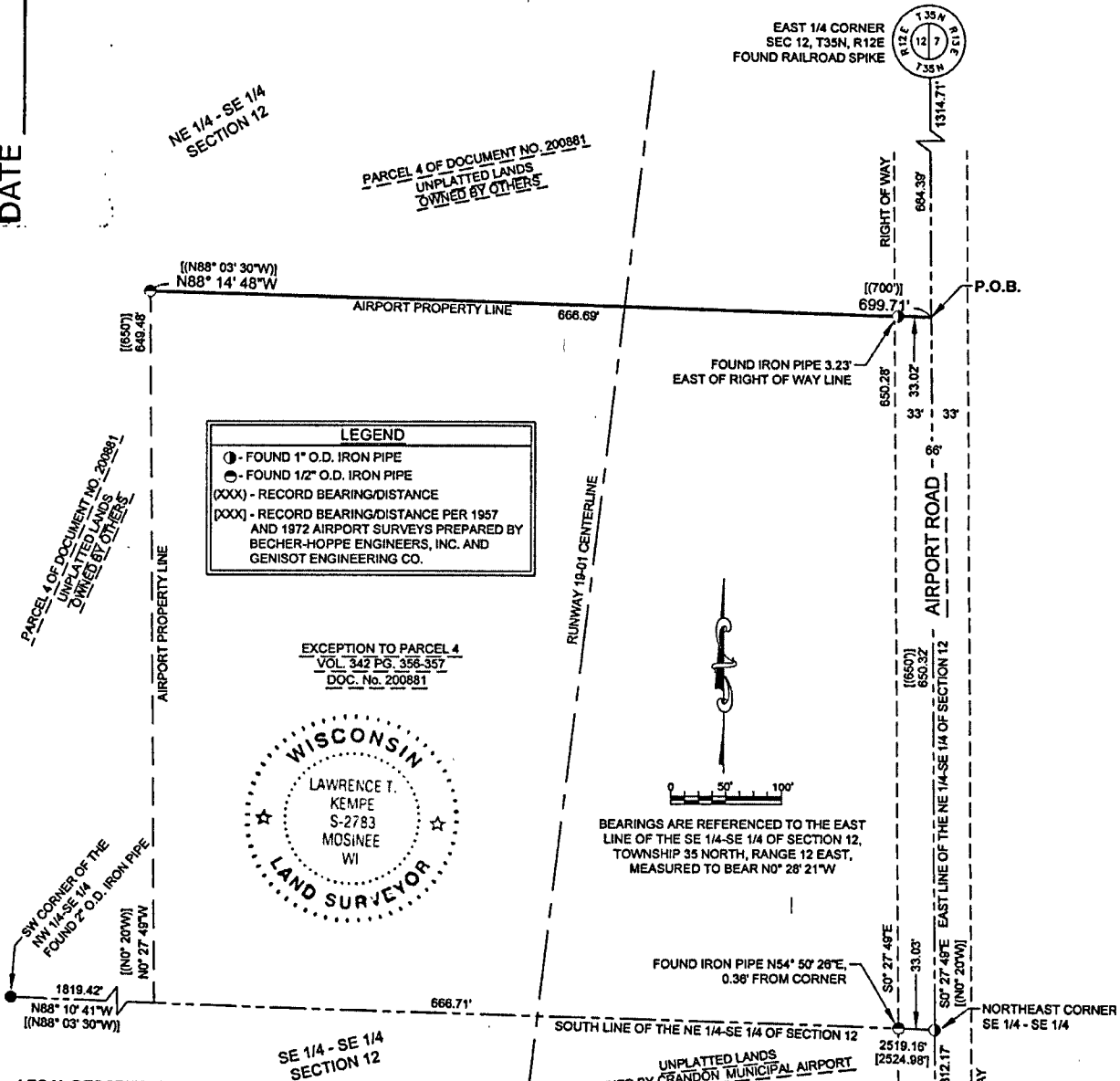

LEGAL DESCRIPTION:

The North line of the exception to Parcel 4 as described in Document No. 200881 being located in the Northeast 1/4 of the Southeast 1/4 of Section 12, Township 35 North, Range 12 East, Town of Nashville, Forest County, Wisconsin; described as follows:

Commencing at the East 1/4 Corner of said Section 12; Thence South 0°27'49" East along the East line of said Northeast 1/4 of the Southeast 1/4, 664.39 feet to said North line of the exception to Parcel 4 which is the point of beginning of said surveyed line; Thence North 88°14'48" West along said North line, 699.71 feet to the Northwest corner of said exception to Parcel 4 and the point of termination of said surveyed line.
