

# U.S. GOVERNMENT LANDS

BEING THE S.W. 1/2 OF THE N.W. THE S. THE W. 1/2 AND N.E. 1/4 OF THE N.E. 1/4: AND THE W. 1/2 AND S.E. 1/4: SECTION 10, TOWNSHIP 35 NORTH, 1/4 OF THE S.E. RANGE 16 EAST, FOURTH PRINCIPAL MERIDIAN, FOREST COUNTY, WISCONSIN.

#### SURVEY NOTES

This survey was made by the U. S. Department of Agriculture, Forest Service, for the purpose of restoring and establishing corners on the perimeter of Section 10, for establishing subdivisional corners within Section 10, and for locating and marking the boundaries of U. S. Government land on their perimeter and within Section 10, Township 35 North, Range 16 East, Fourth Principal Meridian, Forest County, Wisconsin.

The U. S. Government lands in this section were acquired in 1936.

The original Government subdivision survey of this township was made in 1858.

The corner positions recovered, restored and established by this survey are marked by the monument described in the map legend.

The corner positions established were located to an accuracy of one part in 3000.

The bearings between corner positions are true bearings as determined by solar observations.

The field notes of this survey and a copy of this plat are on file in the Forest Supervisor's Office at Rhinelander, Wisconsin.
