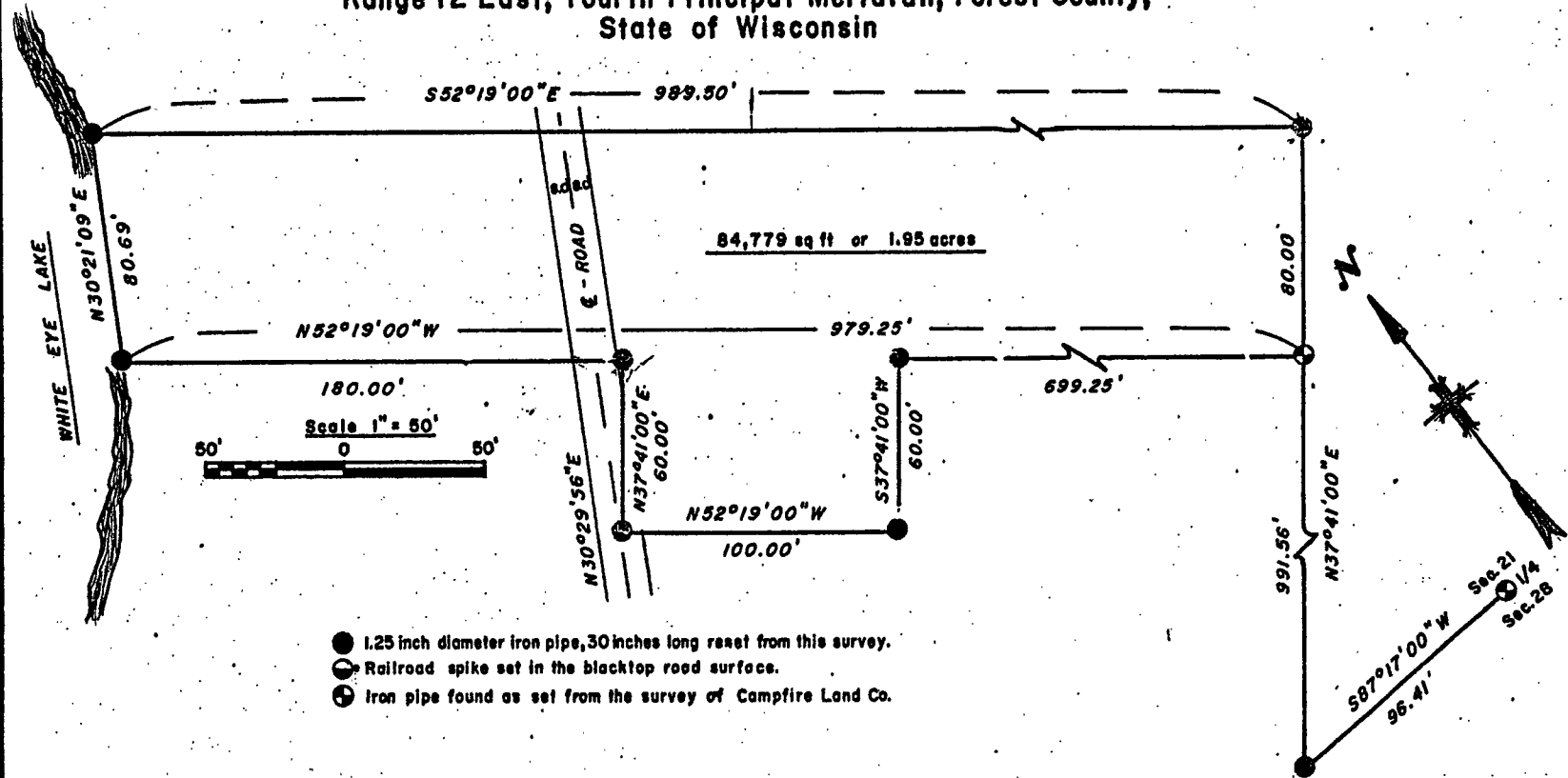

DESCRIPTION OF PARCEL SURVEYED

A parcel known as Lot 4, White Eye Lake Lots located in the Southeast 1/4 of the Southwest 1/4 of Section 21, Township 36 North, Range 12 East, Fourth Principal Meridian, Forest County, State of Wisconsin and described as follows: Commencing at the South Quarter Corner of Section 21; thence South 87° 41' 00" West 96.41 feet; thence North 37° 41' 00" East along a line marked by iron pipes set at 80 foot intervals 991.56 feet to an iron pipe, which pipe marks the Point of Beginning; thence North 52° 19' 00" West 600.25 feet to an iron pipe; thence South 37° 41' 00" West 60.00 feet to an iron pipe; thence North 52° 19' 00" West 100.00 feet to a railroad spike in the blacktop road surface; thence North 37° 41' 00" East 60.00 feet to an iron pipe; thence North 52° 19' 00" West 180.00 feet to an iron pipe on the East shore of White Eye Lake; thence North 30° 21' 09" East along the East shore of White Eye Lake 80.69 feet to an iron pipe on the East shore of White Eye Lake; thence South 52° 19' 00" East 989.50 feet to an iron pipe; thence South 37° 41' 00" West 80.00 feet to an iron pipe and the Point of Beginning.

SURVEY NOTES

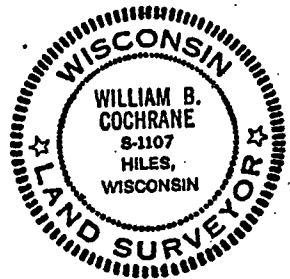
This survey was performed to retrace and reset the exterior boundaries of the above described parcel as shown on the plat of survey by Campfire Land Company. All bearings on this Plat are referenced to the recorded deed descriptions and the survey plat of Campfire Land Company. All linear measurements have been made to the nearest one hundredth of a foot and all angles have been measured to the nearest second of angle.
