Descriptions

Parcel 1

A parcel of land located in the Northeast quarter of the Sortheast quarter of Section 7, Township 36 North, Range 13 East, Town of Lincoln, Forest County, Wisconsin described as follows:

Commencing at the quarter corner to Sections 7 and 8; thence westerly along the east-west quarter line to its intersection with the west right-of-way line coff Wisconsin Highway "32" and "55"; thence Sorth 2° 00' West along the right-of-way line 773 feet, more or less, to the center-line of Seils Lane, a Town Road, and the point of beginning of this description; thence continue South 2° 00' West 34.17 feet to an 1"1 fron pipe set at the intersection of said west right-of-way line and the southerly right-of-way line of Seils Lane; thence continue South 2° 00' West 528 feet, more or less, to the east-west one-sixteenth line; thence westerly along the east-west one-sixteenth 450 feet, more or less; thence North 2° 00' East 406 feet, more or less, to an 1" iron pipe set on the southerly right-of-way line of Siels Lane; thence continue North 2° 00' East 34.17 feet to the center line of Seils Lane; thence North 76°051' 22" East along the center-line 466.19 feet to the point of beginning of this description

This parcel contains 5 acres, more or less.

Subject to a 33 foot public road right-of-way over the northerly end thereof.

Parcel 2

A parcel of land located in the Northeast quarter of the Southeast quarter of Section 7, Township 36 North, Range 13 East, Town of Lincoln, Forest County, Wisconcin described as follows:

Commencing at the quarter corner to Sections 7 and 8; thence westerly along the east-west quarter line of said Siction 7 to its intersection with the west right-of-way line of Wisconsin Highway "32" and""55", the point of beginning of this description; thence South 2° 00' West 738 feet, more or less, to an 1" iron pipe set at the intersection of the west right-of-way line of Highway "32" and "55" and the northerly right-of-way line Seils Lane, a Town Road; thence continue South 2° 00' West 34.17 feet to the center line of Seils Lane; thence South 76° 51' 22" West along the center line 362.58 feet; thence North 2° 00' East 34.17 feet to an 1" iron pipe set on the northerly right-of-way line of Seils Lane; thence continue North 2° 00' East 833 feet, more of less, to the east-west quarter Section line; thence easterly along said quarter line 350 feet, more of less, to the point of beginning of this description

This parcel contains 6 acres, more of less. Subject to a 33 foot public road right-of-way over the northerly end thereof.
