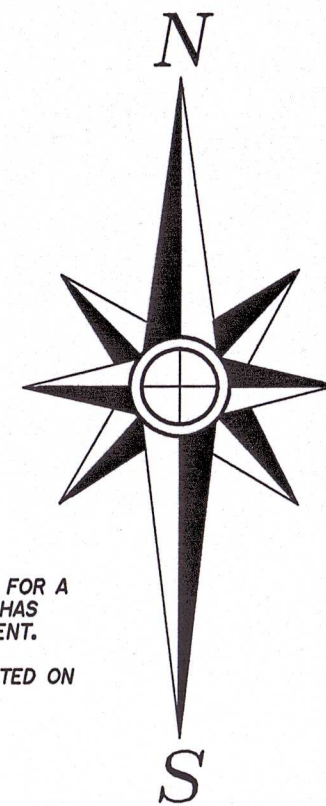

Grid North

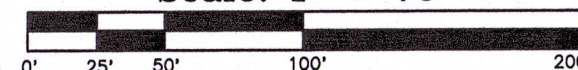
