

SURVEY NOTES

This survey was made by the U. S. Department of Agriculture, Forest Service, for the purpose of restoring and establishing corners on the west boundary of Sections 19 and 30, and for locating and marking the boundaries of U. S. Government land on the west boundary of Sections 19 and 30, Township 36 North, Range 16 East, Fourth Principal Meridian, Forest County, Wisconsin.

The U. S. Government lands in these sections were acquired in 1935.

The original government survey of this township was made in 1857 and 1858. John Melendy surveyed Section 19 in 1917.

The corner positions recovered, restored and established by this survey are marked by the monument described in the map legend.

The corner positions established were located to an accuracy of one part in 5000.

The bearings between corner positions are true bearings as determined by solar observations.

The field notes of this survey and a copy of this plat are on file in the Forest Supervisor's Office at Rhinelander, Wisconsin.

Corner restored by retracement of John Melendy's 1917 survey from his quarter corner south through to north sixteenth corner.


