Corner set by Moore and Hastings prior to 1924. The Frydrych family bought land from Moore and Hastings in the late 1920's and in the 1930's. Walter Frydrych observed the iron pipe at the center of section till the Town of Armstrong Creek relocated the access road to Forest Lake in the early 1970's.

Walter Janczy of Armstrong Creek, construction worker, observed the iron pipe in

place prior to road construction.

Vernon Wickstrom, surveyor, on unrecorded Plat of Forest Lake shows iron pipe at center of Section. Plated about 1960.

Henry J. Willis tied Certified Survey to iron pipe at the center of Section in

October of 1969, prior to road construction. Reset center of section using distances and tie given on H.J. Willis's Certified Survey Map. Corner falls on old fence line determined by butt ends of old fence post beginning to protrude from the road surface. and approximately 16 feet east of a fence line running south. Walter Frydrych reports that the fence line running south was built on the west line of a proposed 2 rod road.
