Commencing at the Northwest corner (2" PIPE) of said Northeast one-quarter of the Northwest one-quarter of Section 1, T37N, R16E; thence S 00°00′00" E along the 1/16th line of 956.86 feet to a capped pin 14 feet North of the North shore of Forest Lake; thence N 83°02′51"E along said shore a distance of 120.00 feet to a found 1-1/2" pipe; thence S 86°29′01"E along said shore 74.87 feet to a set capped pin; thence N 73°42′09"E along said shore a distance of 136.38 feet to a computed point; thence S 79°07′34"E along said shore a distance of 89.50 feet and the **POINT OF BEGINNING**.



Thence N 17°20'26"W a distance of 138.12 feet to a set capped pin on the South right of way of Forest Lake Drive; thence N 57°28'25"E a distance of 50.00 feet to a found 1-1/2" pipe lying within said right of way; thence S 17°31'15"W a distance of 167.54 feet to a found 1-1/2" pipe on the North shore of Forest Lake; thence N 88°50'46"W along the shore line of Forest Lake a distance of 51.44 feet to a set capped pin back to the **POINT OF BEGINNING.**

Beginning at the Northwest corner (2" PIPE) of said Northeast one-quarter of the Northwest one-quarter of Section 1, T37N, R16E; thence East along the section line a distance of 1290 feet more or less to a point of intersection with the Northeasterly right of way of Forest Lake Drive; thence South to North shore of Forest Lake this point to reference point A; thence returning to the Point of Beginning; thence South along the 1/16th line 818 feet more or less to the North right of way of Forest Lake Drive; thence East and Northeasterly along said North right of way of Forest Lake Drive a distance of 820 feet more or less; thence Southeast across roadway 50 feet; thence S 18°50'E to the North shore of Forest Lake; thence Northeasterly along the shore of Forest Lake a distance of 540 feet more or less to **Reference point A**.
