
PROPERTY SURVEY MAP

DESCRIPTION:

A parcel of land located in the SE% of the NE% of Section 36, T37N, R16E. Town of Armstrong Creek, Forest County, Wisconsin, described as follows:

Commencing at the E^{1}_{κ} corner of said Section 36 thence N 0° 12' 16" E, 690.40 to an iron pipe set on the Section Line and the North right-of-way line of the Soo Line Railroad Grade and the point of beginning of this description;

Thence N 69° 49' 45" W along the said North right-of-way line, 627.03 feet to an iron pipe set on a meander line on the East side of a creek;

Thence N 44° 06' 55" E, along the Meander Line 529.85' feet to an iron pipe set;

Thence continue N 44° 06' 55" E 33.63 feet to the center line of the existing bituminous surface on Kus Road;

Thence S 87° 53' E 198.65' feet along said center line to a point on the NOrth South Section Line, said point is 8.41 feet Southerly of an iron pipe at the 1/16 corner;

Thence S 0° 12' 16" W 25.01" feet to an iron pipe set:

Thence continue S 0° 12' 16" W, 588.41 to an iron pipe and the point of beginning of this description.

This parcel includes all that land lying between the Soo Line Railroad right-of-way, the center line of the existing bituminous surface on Kus Road, the above described meander line and the thread of the above mentioned creek.

This parcel contains 5.09 acres to the meander line and 0.4 acres between the meander line and the creek.
