



SURVEY NOTES

This survey was made by the U. S. Department of Agriculture, Forest Service, for locating and marking the boundaries of U. S. Government land from the northeast section corner to the east quarter corner, Section 23, Township 38 North, Range 14 East, Fourth Principal Meridian, Forest County, Wisconsin.

The U. S. Government lands in the east half of the northeast quarter of Section 23 were acquired in 1982.

The original Government subdivision survey of this township was made in 1865.

The corner positions recovered by this survey are marked by the monument described in the map legend.

The bearings between corner positions are true bearings as determined by solar observations.

The field notes of this survey and a copy of this boundary line establishment map are on file in the Forest Supervisor's Office at Rhinelander, Wisconsin.
