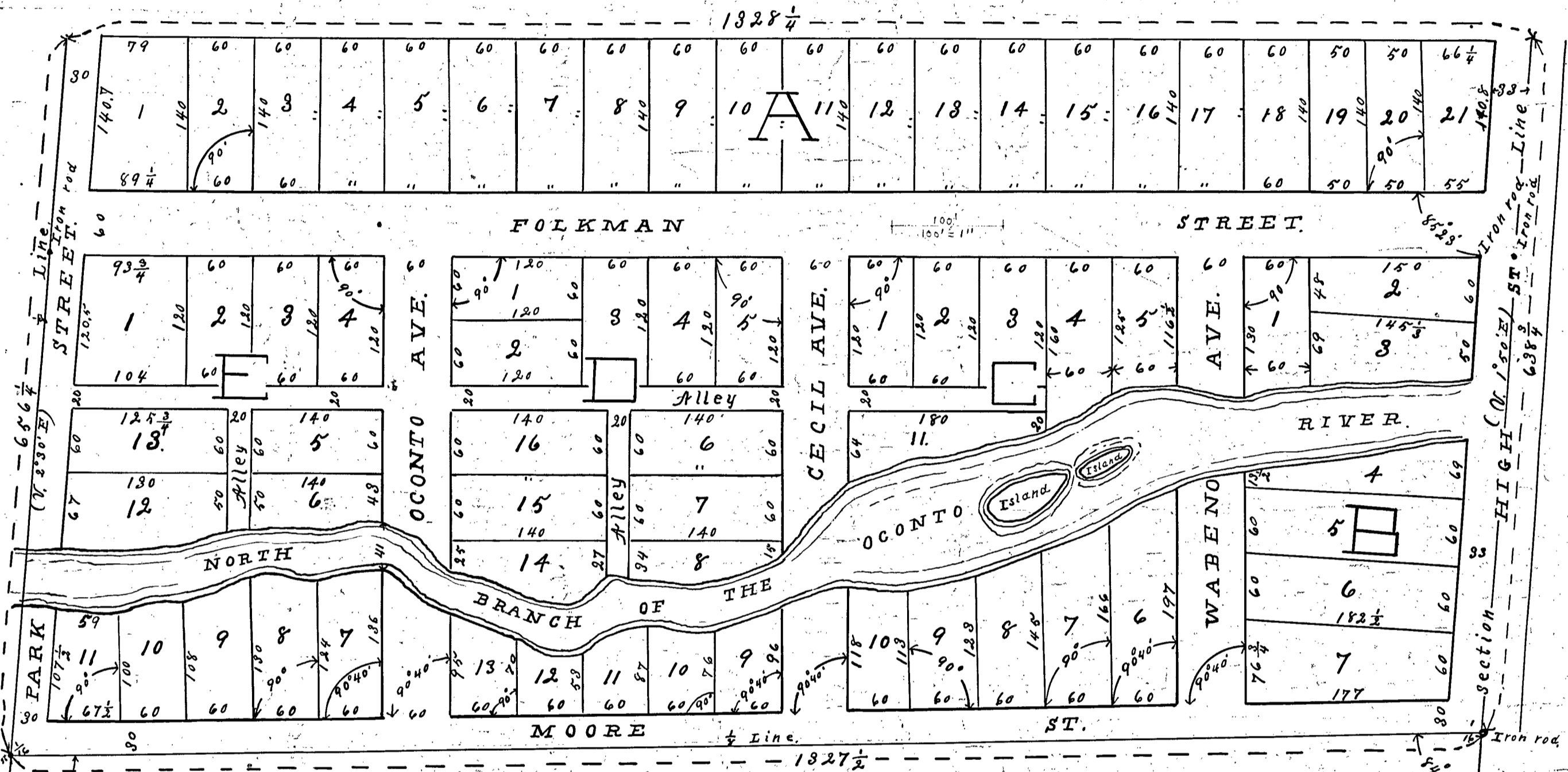

plat into blocks, lots, streets and alleys all of that part of the N. E. quarter of the S. E. quarter of Section No. 7, Township No. 34 N., R. No. 15 E. as represented on the  
above plat by the order and direction of the said owner; that said map is a correct representation of all of the exterior boundaries of the land sur-  
veyed and of the divisions thereon made, that in surveying subdividing and mapping the same into blocks, lots, streets and alleys I have  
fully complied with the provisions of Chapter 101 of the Revised Statute of 1898. All of the lines of lots in Blocks C, D and E that front on
