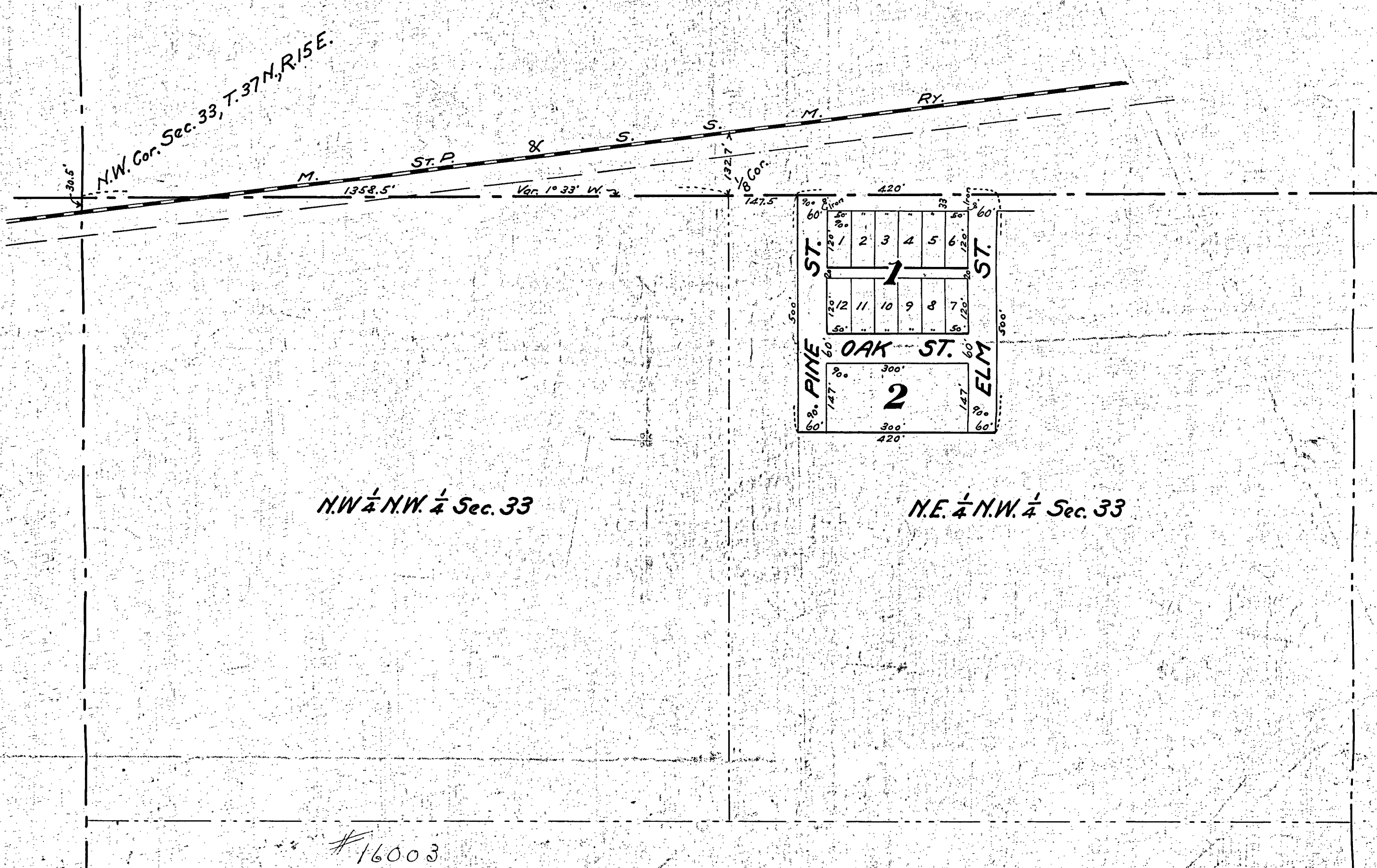

I, N.H.
