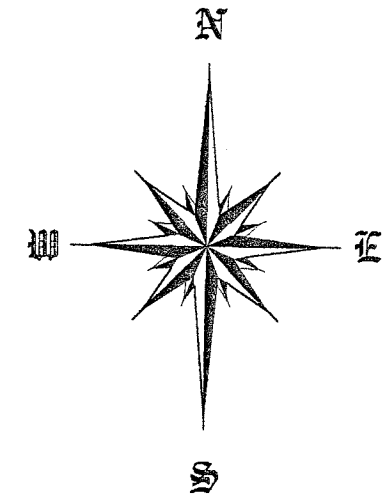

LOCATION \ DESCRIPTION

PART OF GOVERNMENT LOT 7, SECTION 11, T34N-R11E, TOWN OF ELCHO, LANGLADE COUNTY, WISCONSIN DESCRIBED AS: COMMENCING AT A STAKE ON THE WEST LINE OF BLOCK 2 OF SUNSET VIEW PARK, ACCORDING TO THE RECORDED PLAT THEREOF, 400 FEET NORTHEAST OF THE SOUTHWEST CORNER OF SAID BLOCK, THENCE CONTINUING ON SAID BLOCK LINE NORTHEASTERLY A DISTANCE OF 50 FEET TO A STAKE, THENCE RUNNING EASTERLY ACROSS SAID BLOCK PARALLEL WITH THE NORTHEAST END THEREOF TO A STAKE ON THE EAST SIDE OF SAID BLOCK, THENCE SOUTHWESTERLY ON SAID EAST LINE OF SAID BLOCK A DISTANCE OF 50 FEET, THENCE WESTERLY ACROSS SAID BLOCK TO THE PLACE OF BEGINNING, REPRESENTING A PARCEL OF LAND OF THE UNIFORM WIDTH OF 50 FEET ACROSS SAID BLOCK. 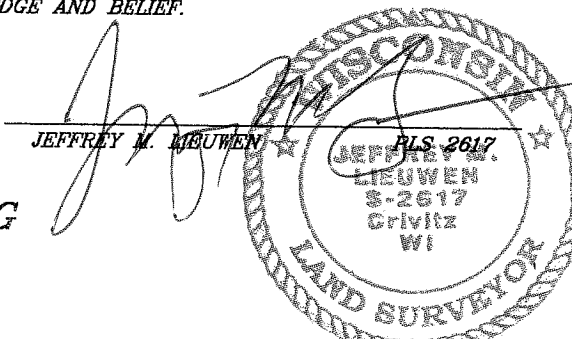
