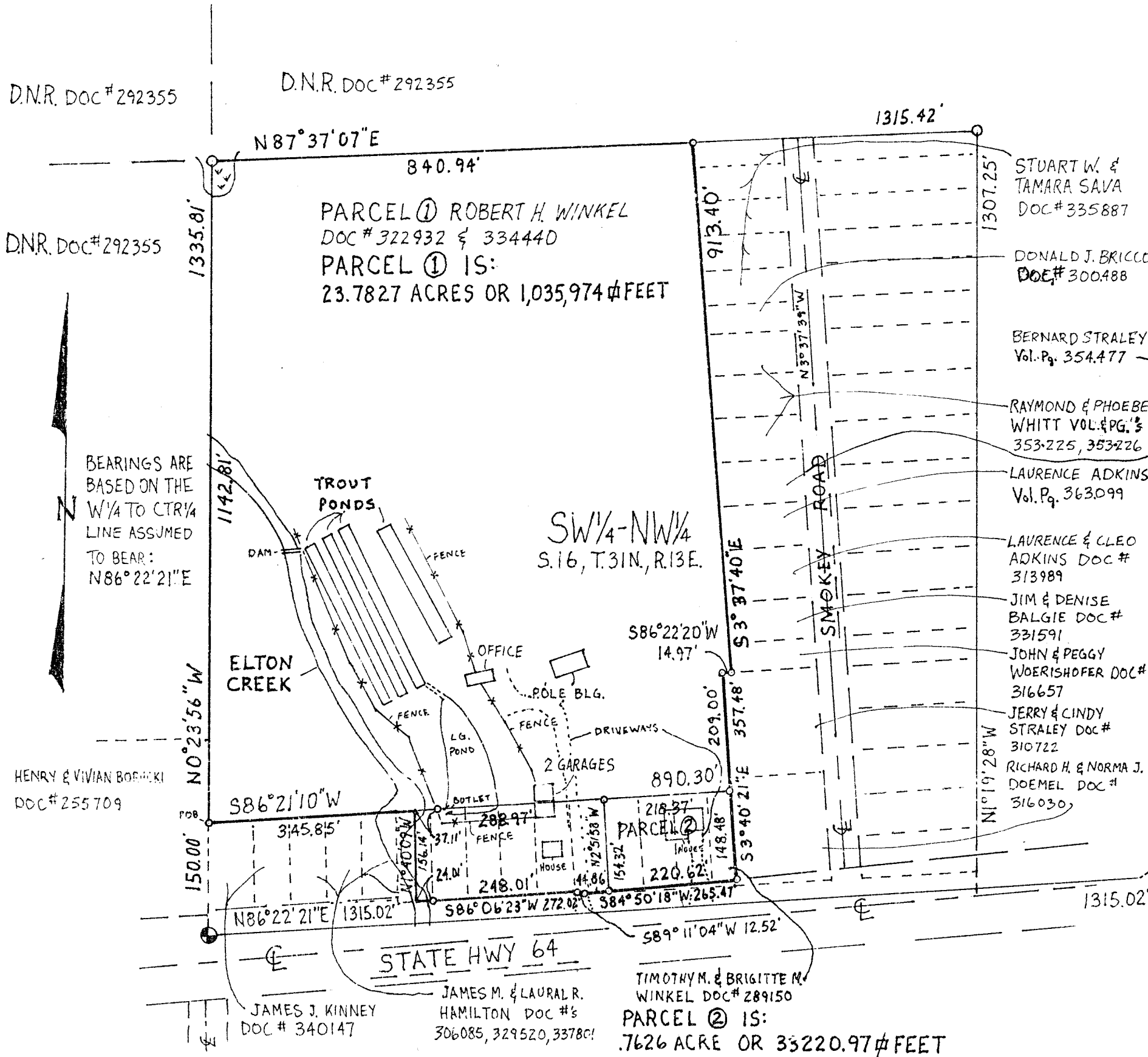


MAP OF SURVEY

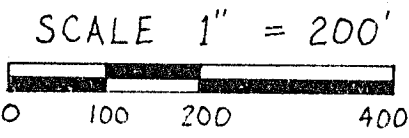
LEGAL DESCRIPTION

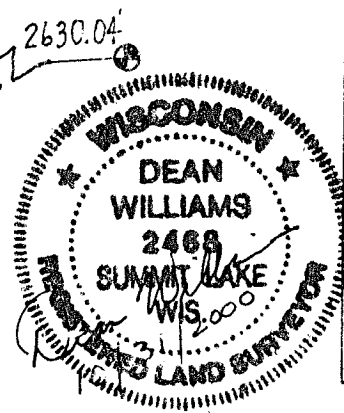
