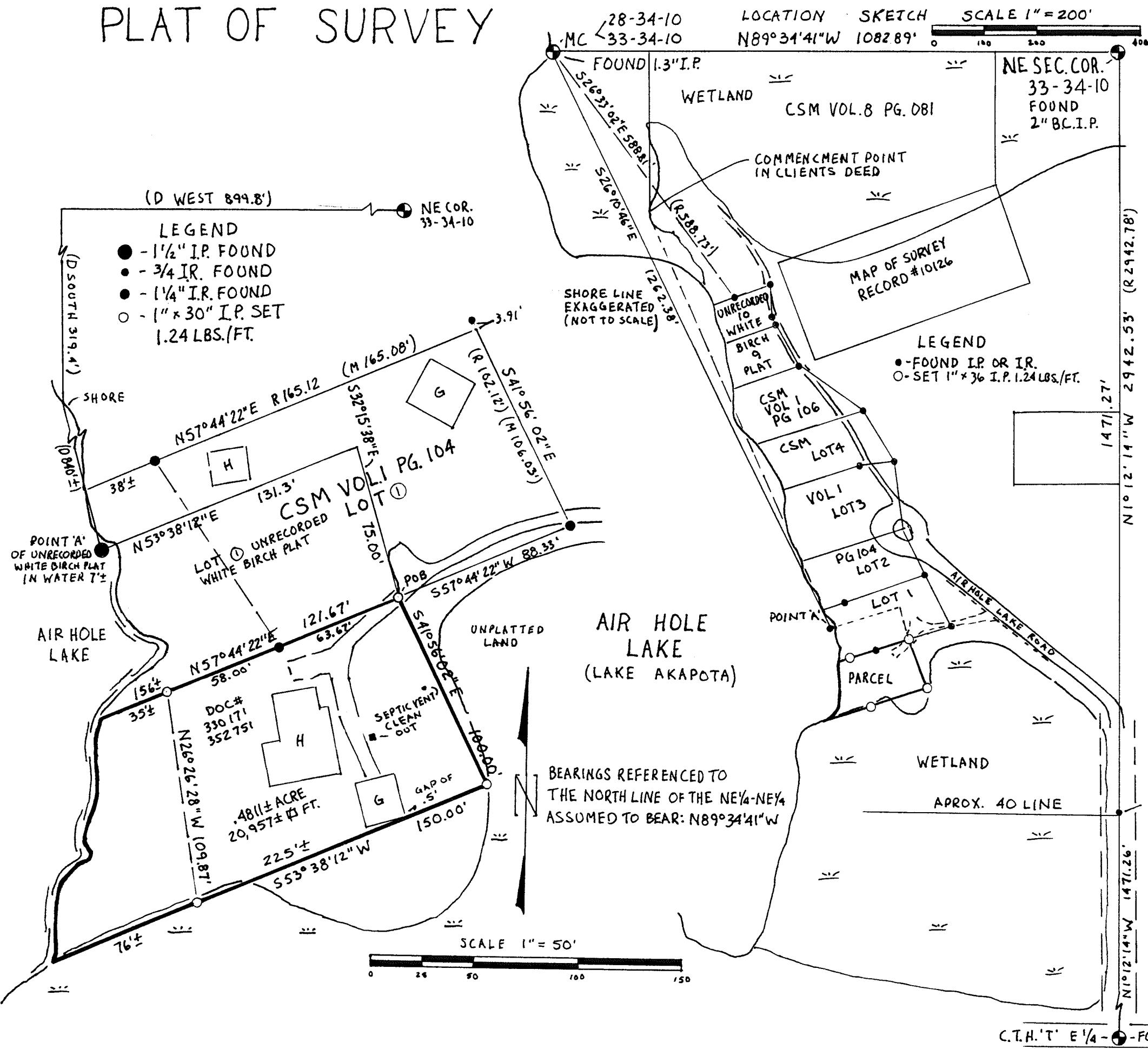


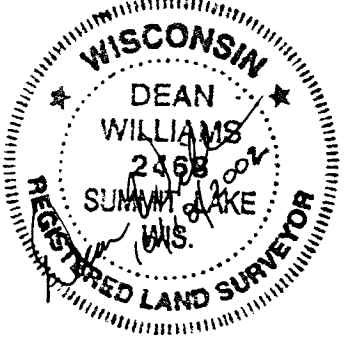

COMMENCING AT THE NORTHEAST CORNER OF SECTION 33, T34N, R10E RUNNING ON THE SECTION LINE N89°34'41"W, 1082.89 FEET TO A IRON PIPE BEING THE MEANDER CORNER ON EAST SHORE OF AIRHOLE LAKE; THENCE S26°10'46"E, 1262.38 FEET TO A IRON PIPE KNOWN AS POINT 'A'; THENCE N53°38'12"E 131.3 FEET TO A POINT; THENCE S32°15'38"E, 75.00 FEET TO AN IRON PIPE AND THE POINT OF BEGINNING; THENCE S41°56'02"E, 100.00 FEET TO AN IRON PIPE; THENCE S53°38'12"W, 150.00 FEET TO AN IRON PIPE; THENCE N26°26'28"W, 109.87 FEET TO AN IRON PIPE; THENCE N57°44'22"E, 58.00 FEET TO AN IRON ROD; THENCE CONTINUING N57°44'22"E, 63.67 FEET TO THE POINT OF BEGINNING. INCLUDING ALL THE LAND LYING BETWEEN THE ABOVE DESCRIBED MEANDER LINE AND THE WATER'S EDGE OF AIRHOLE LAKE. PARCEL CONTAINS .4811± ACRES OR 20,957± SQUARE FEET.
