

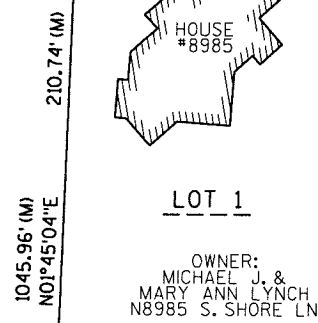

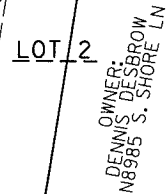

M.C. 2" DIA. IRON PIPE W/BRASS CAP, FOUND

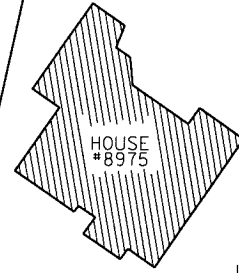

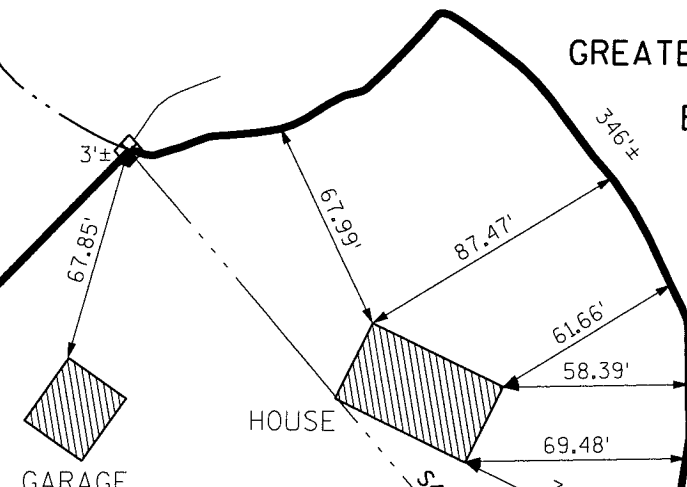
