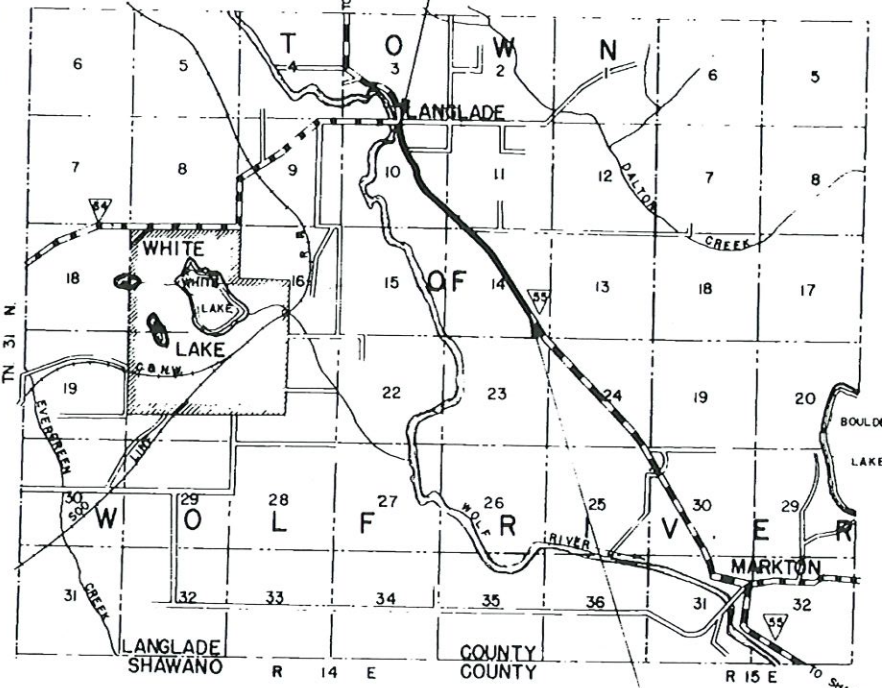

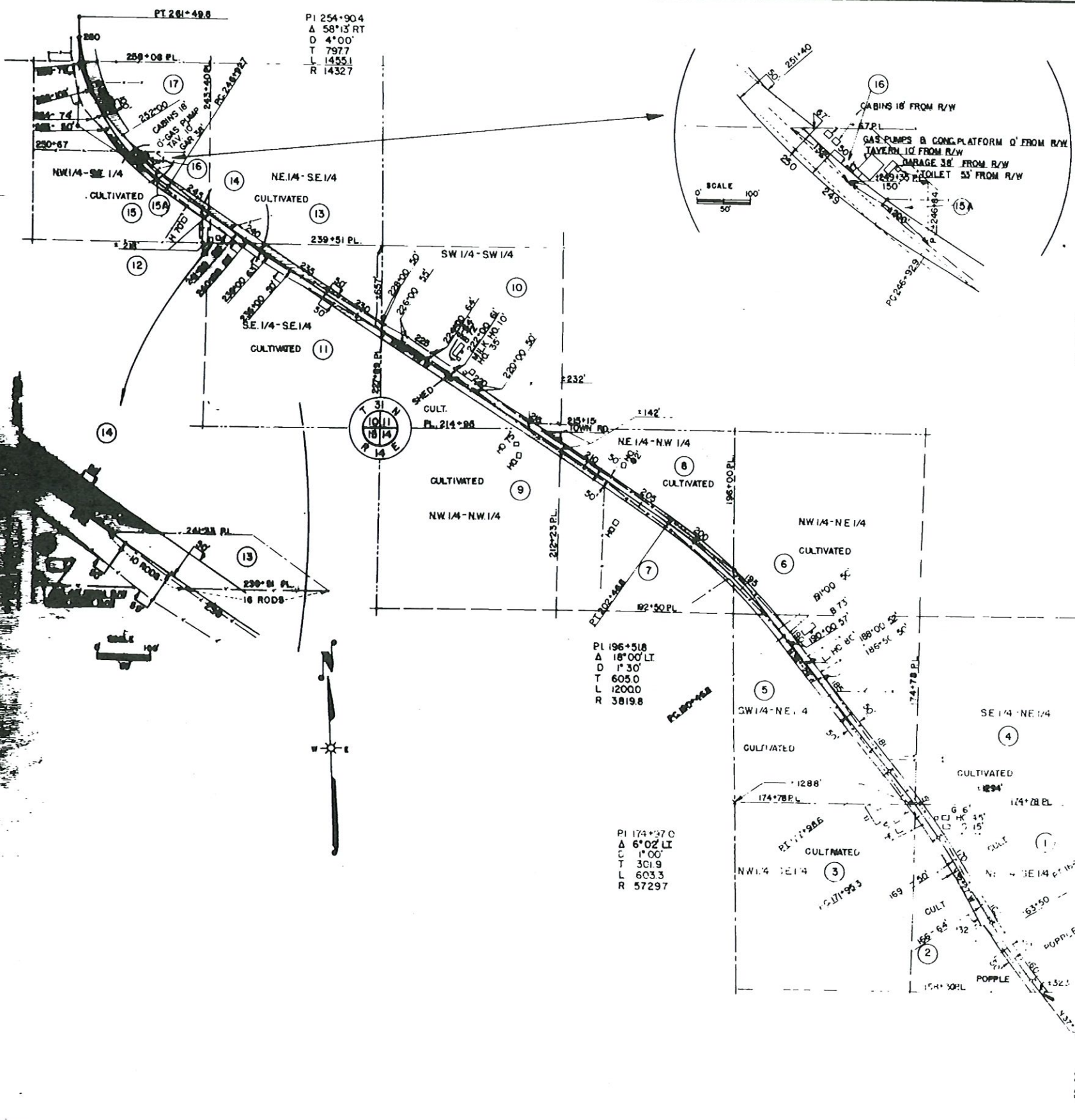
LOCATION SKETCH

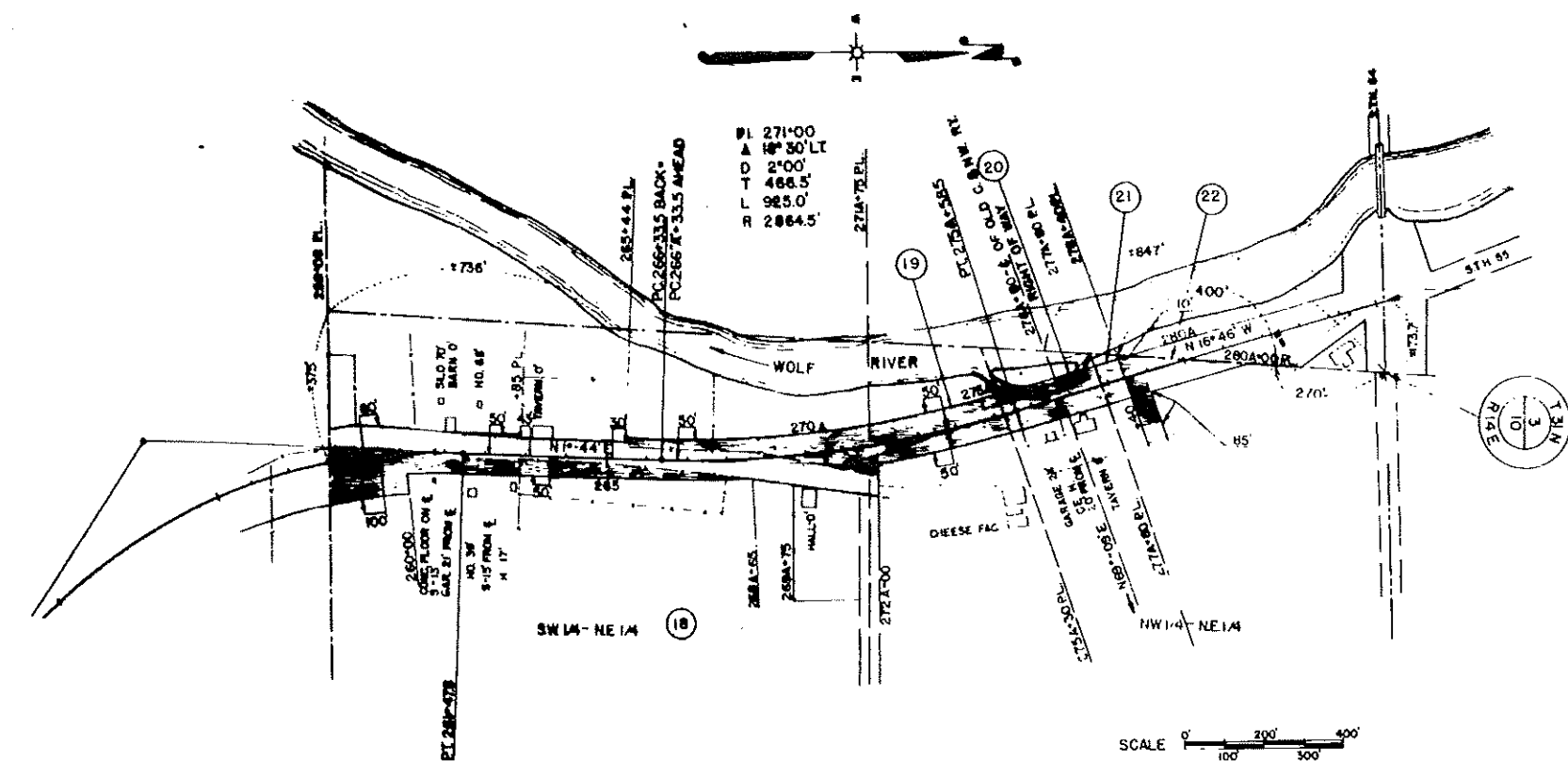
