Parcel "A"

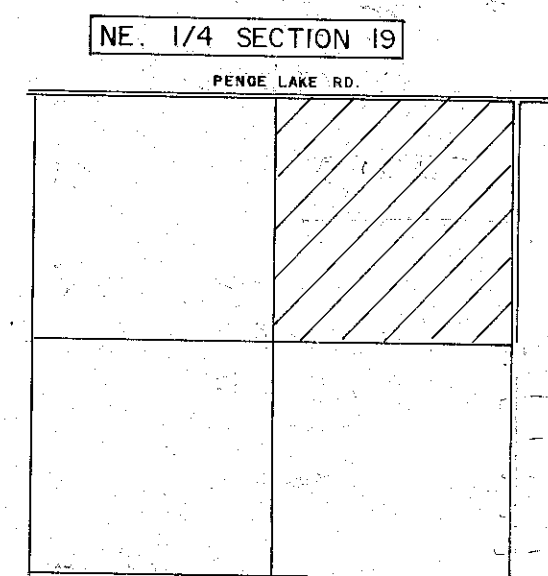
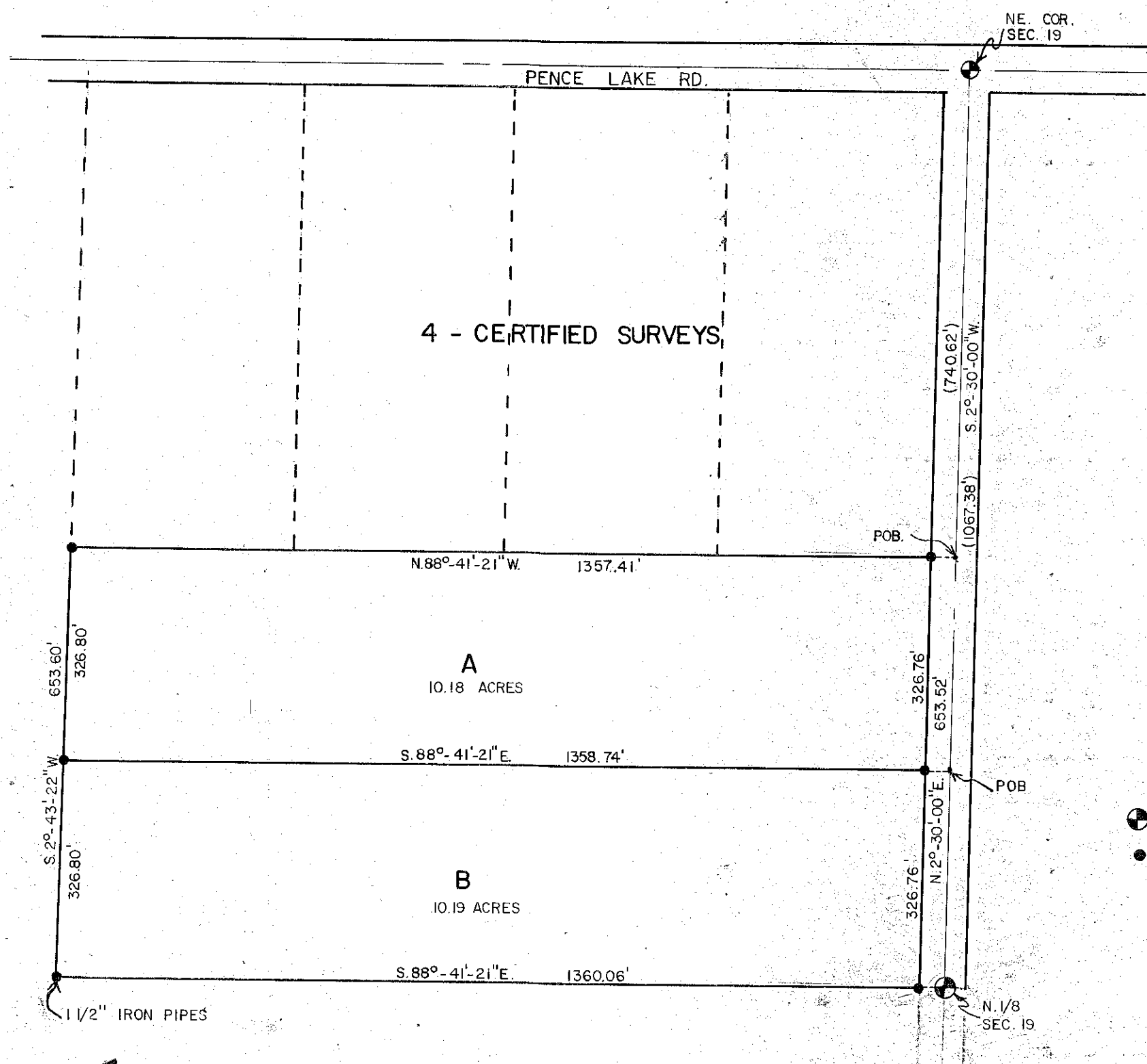
Commencing at the Northeast Corner of Section 19, Town 33 North, Range 11 East, Town of Upham-East Part, Langlade County, Wisconsin; Thence S2°-30'-00"W along the East Section Line of Section 19 and also the centerline of Town Road, 740.62 feet to the Point of Beginning; Thence N88°-41'-21"W, 1357.41 feet to the East one-eighth Line of Section 19; Thence S2°-43'-22"W along the East one-eighth Line of Section 19, 326.80 feet; Thence S88°-41'-21"E, 1358.74 feet to the East Section Line of Section 19 and the centerline of Town Road; Thence N2°-30'-00"E along the East Section Line of Section 19 and also the centerline of Town Road, 326.76 feet to the Point of Beginning.

Parcel "B"

Commencing at the Northeast Corner of Section 19, Town 33 North, Range 11 East, Town of Upham-East Part, Langlade County, Wisconsin; Thence S2°-30'-00"W along the East Section Line of Section 19, and also the centerline of Town Road, 1067.38 feet to the Point of Beginning; Thence N88°-41'-21"W, 1358.74 feet to the East one-eighth Line of Section 19; Thence S2°-43'-22"W along the East one-eighth Line of Section 19, 326.80 feet to the North one-eighth Line of Section 19; Thence S88°-41'-21"E along the North one-eighth Line of Section 19, 1360.06 feet to the East Section Line of Section 19 and also the centerline of Town Road; Thence N2°-30'-00"E along the East Section Line of Section 19 and also the centerline of Town Road, 326.76 feet to the Point of Beginning.
