

DESCRIPTION

A parcel of land located in the Southwest one-quarter (SWM) of the Northwest one-quarter (NWM) of Section 35, T.33N., R.10E., Town of West Upham, Langlade County, Wisconsin, being more particularly described as follows:

Commencing at the Southwest Corner of said Section 35, T.33N., R.10E., Langlade County, Wisconsin, Thence NO°-OO'-OO'E along the West Section Line of said Section 35, 2351.58 feet to the West one-quarter (W%) of said Section 35, Thence N90°-OO'-OO'E, 33.00 feet to the East Right of Way Line of Begin Road and the Point of Beginning, Thence N90°-OO'-OO'E, along the East - West Center Section Line of said Section 35, 344.05 feet to the West Shore Line of Black Oak Lake, Thence northerly on a meander line along the West Shore Line of Black Cak Lake, 475.00 feet, Theme S90°-OO'-OO'W, 420.50 feet to the East Right of Way Line of Begin Road, Thence SO°-OO'-OO'W, along the East Right of Way Line of Begin Road, 475.00 feet to the Point of Beginning.

Parcel A... Commencing at the West one-quarter (WA) of said Section 35, Thence N90°-00"E, 33.00 feet to the East Right of Way Line of Begin Road, Thence N0°-00'-CO"E along the East Right of Way Line of Begin Road 100.00 feet to the Pt.tof Beginning of Parcel A, Thence N90°-00'-00"E, 383.75 feet to the West Shore Line of Black Oak Lake, Thence northerly on a meander line along the West Shore Line of Black Oak Lake, 150.00 feet, Thence S90°-00'-00"W, 406.00 feet to the East Right of Way Line of Begin Road, Thence S0°-00'-00"W along the East Right of Way Line of Begin Road, 150.00 feet to the Pt. of Beginning of Parcel A.

Parcel B... Commencing at the West one-quarter of said Section 35, Thence N90°-00'-00"E, 33.00 feet to the East Right of Way Line of Begin Road, Thence N0°-00'-00"E along the East Right of Way Line of Begin Road, 250.00 feet to the Pt. of Beginning of Parcel B, Thence N90°-00'-00"E, 406.00 feet to the West Shore Line of Black Oak Lake, Thence northerly on a meander line along the West Shore Line of Black Oak Lake, 225.00 feet, Thence S90°-00'-00"W, 420.50 feet to the East Right of Way Line of Begin Road, Thence S0°-00'-00"W, along the East Right of Way Line of Begin Road, 225.00 feet to the Pt. of Beginning of Parcel B.
