

DESCRIPTION OF PARCEL NUMBER ONE

A parcel of land which is part of Lot 31-6 of the Assossors Plat of the Northeast one-quarter (NE $\frac{1}{4}$ ) of the Southeast one-quarter (SE $\frac{1}{4}$ ) of Section 31, Town 31 North, Range 11 East, Town of Antigo, Langlade County, Wisconsin.

The point of beginning being the intersection of the south line of Forest Avenue and the east right-of-way line of the Chicago Northwestern railroad; THENCE N90°00'00"E along the south line of Forest Avenue, 33.21 feet; THENCE S06°22'20"W along a line parallel to the railroad right-of-way, 290.00 feet; THENCE N90°00'00"E along a line parallel to Forest Avenue, 132.89 feet; THENCE S06°23'40"W, 1011.85 feet; THENCE N89°17'59"W, 165.49 feet to the east line of the Railroad right-of-way; THENCE N06°22'20"E along the east line of the Railroad right-of-way, 1299.77 feet to the point of beginning.

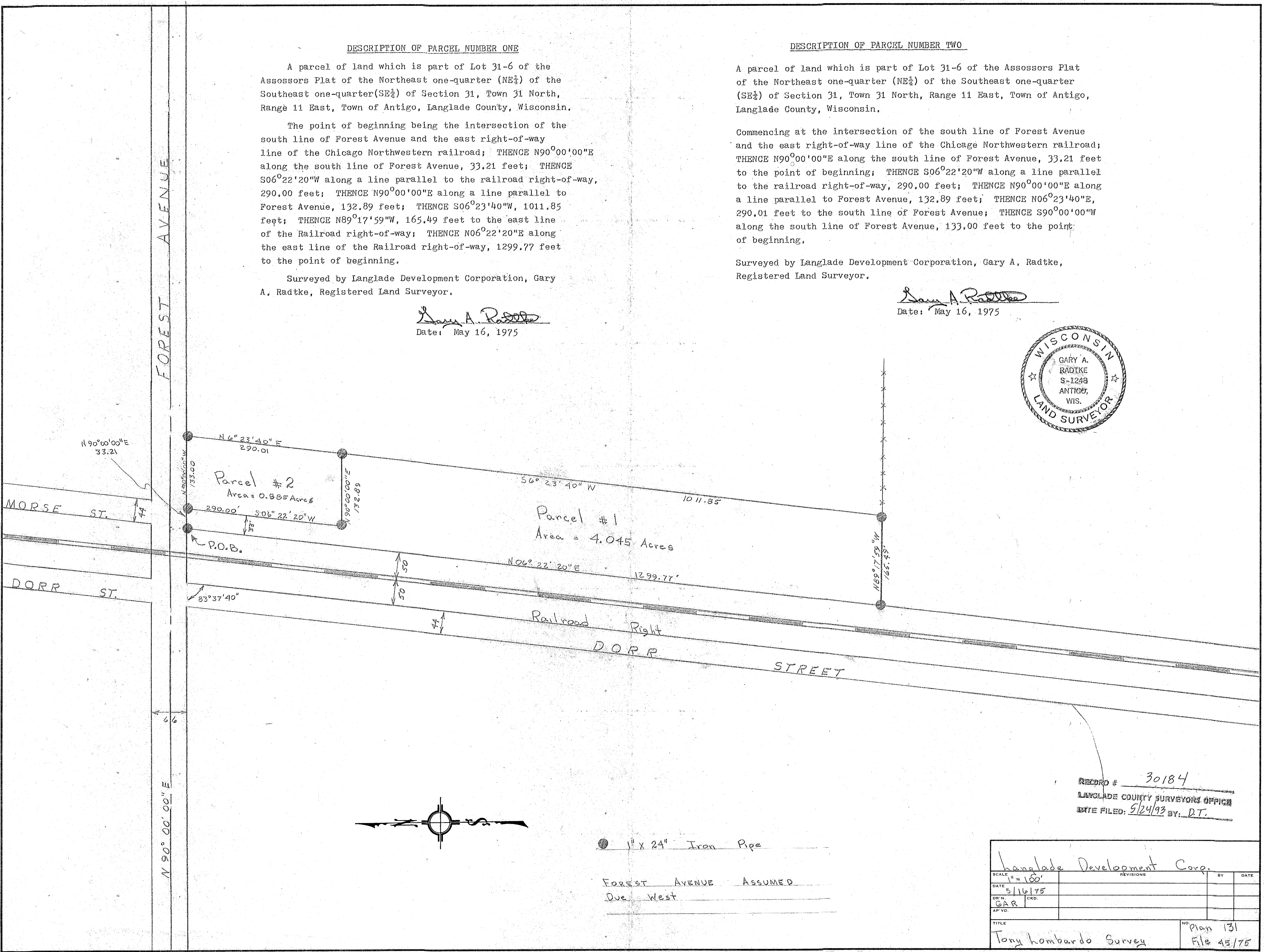
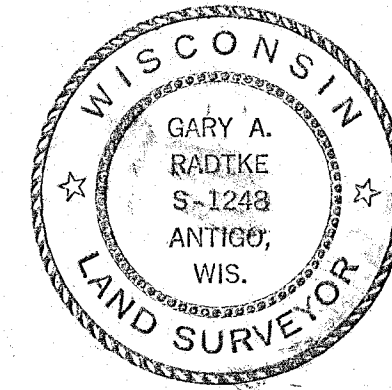
DESCRIPTION OF PARCEL NUMBER TWO

Commencing at the intersection of the south line of Forest Avenue and the east right-of-way line of the Chicago Northwestern railroad; THENCE N90°00'00"E along the south line of Forest Avenue, 33.21 feet to the point of beginning; THENCE S06°22'20"W along a line parallel to the railroad right-of-way, 290.00 feet; THENCE N90°00'00"E along a line parallel to Forest Avenue, 132.89 feet; THENCE N06°23'40"E, 290.01 feet to the south line of Forest Avenue; THENCE S90°00'00"W along the south line of Forest Avenue, 133.00 feet to the point of beginning.
