## SURVEYORS CERTIFICATE

I HEREBY CERTIFY THAT I HAVE, WITHIN THE LAST THIRTY DAYS SURVEYED, SUBDIVIDED AND PLATTED THE LAND REPRESENTED BY THIS MAP, BY DIRECTION OF JOHN W. KENNEDY, THE OWNER OF SAID LAND, THAT SAID MAP IS A CORRECT REPRESENTATION OF ALL BOUNDARIES OF LAND SURVEYED AND SUBDIVIDED, AND THAT IN SURVEYING, SUBDIVIDING AND PLATTING THE SAME, I HAVE FULLY COMPLIED WITH CHAPTER 236 OF THE REVISED STATUTES OF THE STATE OF WISCONSIN FOR THE YEAR 1923, AND ALL ACTS AMENDATORY THEREOF AND SUPPLEMENTAL THERETO.

THE LAND ENCLOSED IN THIS MAP IS DESCRIBED AS A PART OF GOV'T LOT 2 SEC. 35 T. 33N. R. 10E AS FOLLOWS: STARTING AT A POINT ON THE EAST BANK OF LONG LAKE (SAID POINT 165 FEET NORTH AND 735.9 FEET WEST OF THE S.E. CORNER OF SEC 35) THENCE <sup>EAST</sup> PARALLEL TO THE SOUTH LINE OF SEC 35- 463 FEET TO THE NORTH LINE OF THE HIGHWAY (COUNTY TRUNK J) THENCE NORTHEAST ALONG NORTH LINE OF HIGHWAY 43 FEET. THENCE WEST PARALLEL TO THE SOUTH LINE OF SEC. 35- 316 FEET, THENCE N36°22'W 190 FEET. THENCE NORTH 883 FEET TO THE BANK OF LONG LAKE, THENCE SOUTHWEST AND SOUTH ALONG THE EAST BANK OF LONG LAKE TO PLACE OF BEGINNING. THE FIGURES IN THE CENTER OF THE LOTS ARE THE NUMBERS OF THE SAME. THE LENGTH AND WIDTH OF THE LOTS ARE REPRESENTED BY THE FIGURES ON THE MARGIN THEREOF.

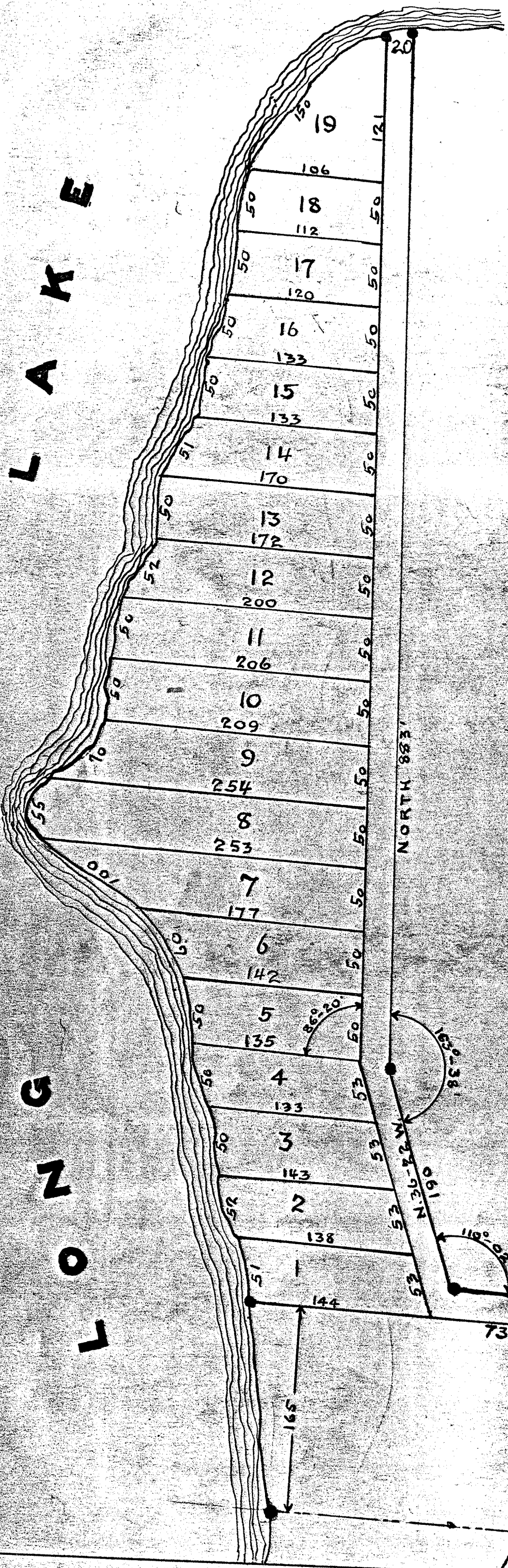
