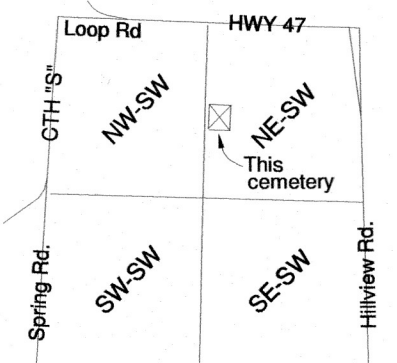


St. Joseph Holy Family Parish Cemetery

DESCRIPTION OF BLOCK 4 OF THE ST. JOSEPH HOLY FAMILY PARISH CEMETERY BOUNDARY
Commencing at the West 1/4 corner of Section 26, T.30N., R12E, thence S 87°52'22" E, along the North line of the SW 1/4 of said Section 26, 1129.76 feet to the Northwest corner of the NE-SW of Section 26, thence S 1°36'19" W, along the West line of said NE-SW, 636.65 feet; thence S 85°50'19" E, 33.72 feet to the point of beginning of the parcel herein surveyed, plotted and described; thence S 85°50'19" E, 160.00 feet; thence S 4°09'41" W 132.00 feet; thence N 85°50'19" W, 160.00 feet; thence N 4°09'41" E, 12.00 feet; thence N 85°50'19" W, 8.00 feet; thence N 4°09'41" E 108.00 feet; thence S 85°50'19" E, 8.00 feet; thence N 4°09'41" E, 12.00 feet to the point of beginning.
