

ALONG SAID NORTH LINE OF ENTERPRIZE LAKE ROAD, 550.08'; THENCE N.1°40'30"E., 160.00 FEET; THENCE N.57°16'00"E., 274.95 FEET; THENCE N.3°42'00"E., 209.51 FEET; THENCE N.81°59'50"W., 186 FEET MORE OR LESS TO THE SHORE OF OTTER LAKE; THENCE SOUTHWESTERLY AND THEN NORTHWESTERLY ALONG THE SHORE OF OTTER LAKE, 1600 FEET MORE OR LESS TO A POINT; THENCE S.46°11'10"W., 103 FEET MORE OR LESS TO THE EAST LINE OF FLOWER LANE; THENCE S. 2º47'20"E.
