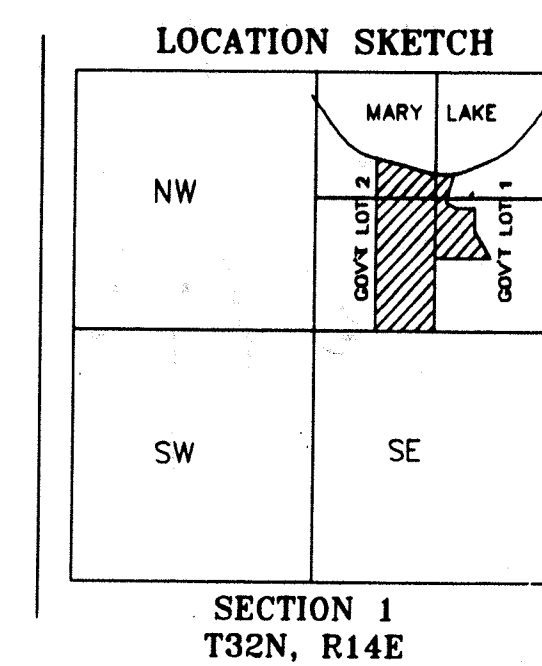


PART OF GOVERNMENT LOT 1 & 2 IN THE NORTHEAST QUARTER,
