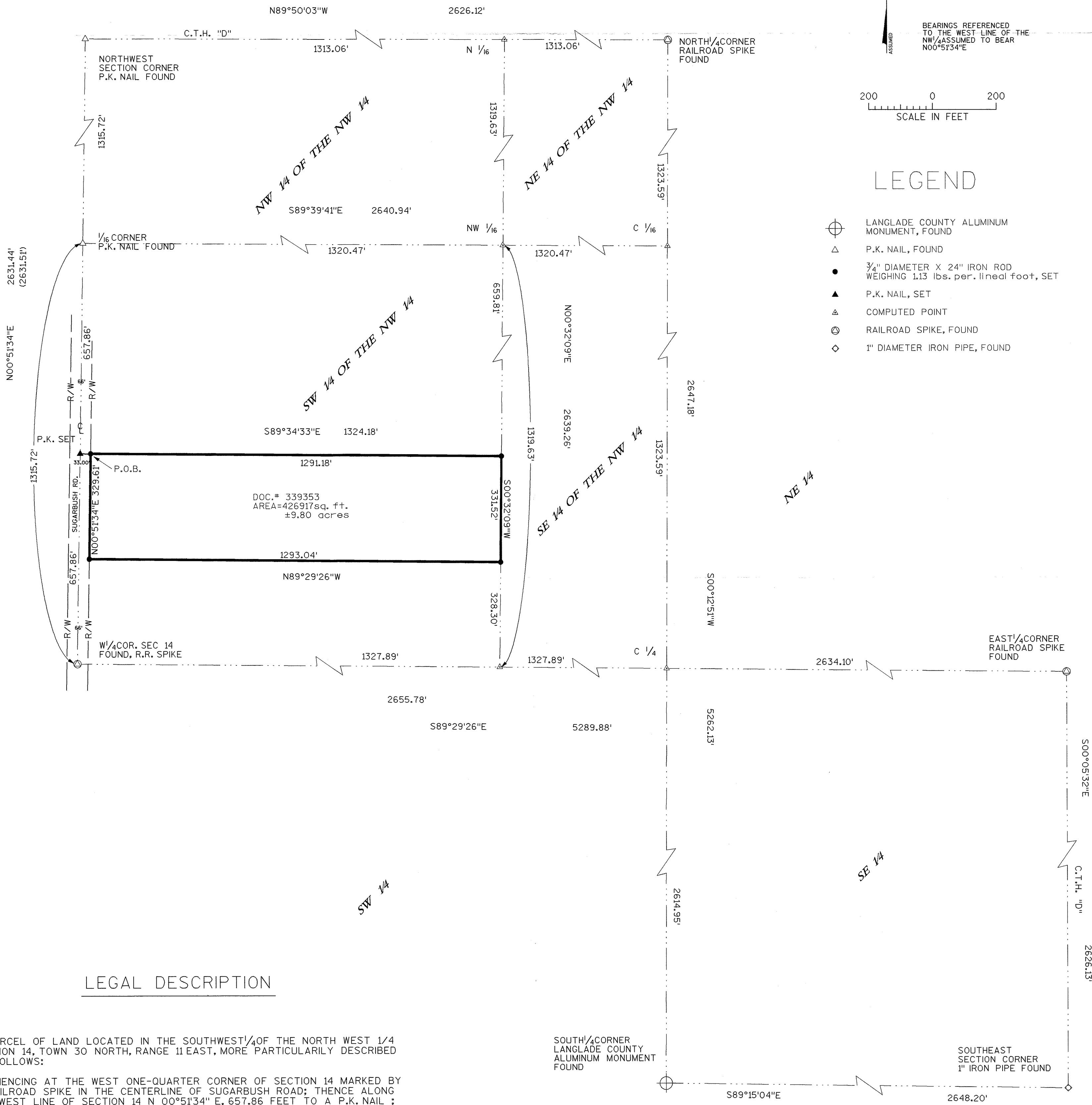


A MAP OF SURVEY FOR ROCHELLE KITTEL

LEGAL DESCRIPTION

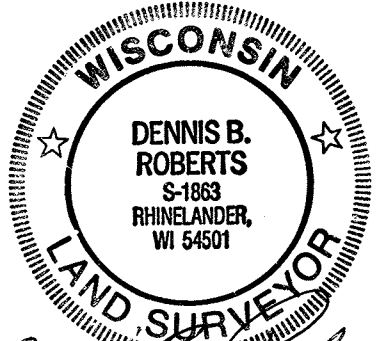
A PARCEL OF LAND LOCATED IN THE SOUTHWEST 1/4 OF THE NORTH WEST 1/4 SECTION 14, TOWN 30 NORTH, RANGE 11 EAST, MORE PARTICULARLY DESCRIBED AS FOLLOWS:

COMMENCING AT THE WEST ONE-QUARTER CORNER OF SECTION 14 MARKED BY A RAILROAD SPIKE IN THE CENTERLINE OF SUGARBUSH ROAD; THENCE ALONG THE WEST LINE OF SECTION 14 N 00°51'34" E, 657.86 FEET TO A P.K. NAIL ; THENCE S 89°34'33" E, 33.00 FEET TO THE EASTERLY RIGHT-OF-WAY LINE OF SUGARBUSH ROAD AND THE POINT OF BEGINNING MARKED BY A 3/4" DIAMETER IRON ROD.

THENCE CONTINUING S 89°34'33" E, 1291.18 FEET TO A 3/4" DIAMETER IRON ROD ON THE EAST LINE OF THE SOUTHWEST 1/4, NORTHWEST 1/4; THENCE S 00°32'09" W, 331.52 FEET ALONG SAID EAST LINE TO A 3/4" DIAMETER IRON ROD; THENCE N 89°29'26" W, 1293.04 FEET TO A 3/4" DIAMETER IRON ROD ON THE EASTERLY RIGHT-OF-WAY LINE OF SUGARBUSH ROAD; THENCE ALONG SAID RIGHT-OF-WAY LINE N 00°51'34" E, 329.61 FEET TO THE POINT OF BEGINNING

SAID PARCEL CONTAINS 9.80 ACRES MORE OR LESS, SUBJECT TO ALL EASEMENTS AND RIGHTS-OF-WAY OF RECORD
