I HEREBY CERTIFY THAT I HAVE SURVEYED, SUBDIVIDED AND PLATTED THE LAND SHOWN ON THIS MAP, BY ORDER OF THE LANGLADE LUMBER COMPANY, A DOMESTIC CORPORATION, THE OWNER OF SAID LAND. THAT SAID MAP IS A CORRECT REPRESENTATION OF ALL BOUNDARIES OF LAND FULLY SURVEYED AND PLATTED AND THAT IN SURVEYING AND PLATTING THE SAME, I HAVE FULLY COMPLIED WITH CHAPTER 236 OF THE REVISED STATUTES OF THE STATE OF WISCONSIN FOR THE YEAR 1923 AND ALL ACTS AMENDATORY THEREOF AND SUPPLEMENTAL THERETO. THE LAND SHOWN ON THIS MAP IS DESCRIBED AS A PART OF GOVERNMENT LOT 6, SECTION 14, T.33N.R.10E. AS FOLLOWS: STARTING AT THE MEANDER CORNER ON THE SOUTH SHORE OF DEEP WOODS LAKE, WHERE THE SECTION LINE BETWEEN SECTIONS 14 AND 15, T.33N.R.10E. INTERSECT THE LAKE, THENCE SOUTH ALONG SAID SECTION LINE 550 FEET TO THE CENTER OF THE HIGHWAY, THENCE ALONG THE CENTER OF THE HIGHWAY, S.55°25'E. 250 FEET, S.24°05'E. 241.0 FEET, S.00°20'E. 133.5 FEET, S.84°20'E. 444.5 FEET, S.63°30'E. 172.5 FEET, S.06°45'W. 68.0 FEET TO THE CENTER OF THE OLD RAILROAD GRADE, THENCE N.66°15'E. 212.0 THENCE N.72°15'E, 32.0 FEET TO THE CENTER OF THE HIGHWAY, THENCE ALONG THE CENTER OF THE HIGHWAY N.13°15'E. 814.0 FEET N.87°45'E. 175.0 FEET TO THE WEST 1/8 LINE OF SAID SECTION 14, THENCE NORTH ALONG SAID 1/8 LINE 200.0 FEET TO THE SHORE OF DEEP WOODS LAKE, THENCE WESTERLY, SOUTHWESTERLY AND NORTHWESTERLY ALONG THE SHORE OF DEEP WOODS LAKE TO THE PLACE OF BEGINNING.
